NEW: Financing of On-site Power Generation

On-site power generation, such as fuel cells and CHP (combined heat and power), are now allowed into the SCEF program. This means that energy service companies (ESCOs) would be able to offer a combination of efficiency retrofits and on-site power generation packages. For some facilities, this could help further offset energy costs.

Audits Are Underway!

The program is moving forward at a great pace. Many participants have already selected an ESCO and are moving forward with their no-cost energy and water efficiency audits. The list of prequalified ESCOs includes Ameresco, Honeywell Building Solutions, Johnson Controls, NORESKO, Schneider- Electric, Siemens Industry, PEPCO and Trane.

Enrollment is about to close for any public schools, governments or non-profits interested in participating in the SCEF program. December 12th will be the final day any entity can enroll. Education Day Success!

On October 19th, 2012, representatives from Sonoma County public and non-profit organizations gathered for a daylong meeting to review and discuss the details of the SCEF program. Also in attendance were the pre-qualified energy service companies (ESCOs) who will be carrying out the retrofit projects. There were great discussions about the program, in which many questions were answered. Those in attendance were able to listen to presentations by the prequalified ESCOs and talk one- on-one with the companies.



What is the SCEF Program?

The Sonoma County Water Agency has launched a program to finance energy efficiency and water conservation retrofits for public and non-profit institutions. The Sonoma County Efficiency Financing (SCEF) program is a scaled down version of a Sustainable Energy Utility (SEU) model which was developed by Dr. John Byrne and his colleagues at the Center for Energy & Environmental Policy at the University of Delaware. The first SEU model was adopted by the State of Delaware and is currently implementing nearly \$73M in energy and water retrofit projects at public facilities in the State.

Under the SCEF Program, participating organizations will contract with an Energy Service Company to complete energy and water conservation measures using standardized contract language that protects the owner. Improvements could include: street lighting; building lighting; pumps; HVAC; system controls; boilers; chillers; ducting; windows; partial roofing; toilets; and others. The participating organizations will receive substantial utility cost savings, including a contractual guarantee sufficient to cover the full cost of all retrofit work. The Program intends to use tax-exempt bonds to finance the projects.
