## Save Water. Save Money.

The Sonoma County Sanitation Water Efficiency Rebate Program was established to help your business save water, lower operating costs, and reduce wastewater flows to your local wastewater treatment plant.

Upgrade your existing water using fixtures, equipment, and infrastructure and get cash rebates that will shorten the return on investment. Using less water often saves energy as well, making improvements more cost effective by lowering your energy costs.

## High-Efficiency Clothes Washers

Get up to **\$125\*** back on the purchase and installation of a new, qualifying high-efficiency clothes washer (HEW). A new washer can use 40 to 60% less water and energy than older, top loading clothes washers.

Rebates are available for EnergyStar® Most Efficient designated clothes washers. For a listing of qualifying clothes washers, visit the EnergyStar® website at <http://www.energystar.gov/most-efficient/me-certified-clothes-washers/> or call (707) 547-1918. **Not all EnergyStar® models qualify** so be sure to check the list. Rebates are only available for clothes washers designated as "Most Efficient" except those containing silver ion technology.



## Water Efficient Ice Machines

Rebates of up to **\$600\*** are available for upgrading ice machines to new, water efficient models. Install an air-cooled ice machine that use 20 gallons per 100 pounds of ice produced or less to qualify.

## High-Efficiency Toilets and Urinals

Get up to **\$300\*** back on the purchase and installation of each new, qualifying high-efficiency toilet (HET) or urinal (HEU).

An **HET** uses, on average, 1.28 gallons per flush (gpf) or less – a minimum of 20% less than the standard 1.6 gpf toilets. Replacing your older toilet saves water and reduces wastewater without sacrificing performance.



An **HEU** uses 0.125 gallons per flush (gpf). Replace a 1.0 gallon per flush urinal and reduce water use by 87%.

**How to Participate**

1. Read and understand the Program Eligibility and Rules.
2. Determine if your commercial property is connected to a participating sanitation system – look on your property tax bill for a line item stating the sanitation district or zone you are connected to or call (707) 547-1918.
3. Contact the Water Efficiency Rebate Program at (707) 547-1918 to get pre-approval for your project.
4. Purchases and install your qualifying high-efficiency fixtures and equipment.
5. For toilets and clothes washers, complete and sign the application form below and mail along with **original** purchase receipts/plumbers invoices to:

6. For other equipment, call for a post-inspection.
7. Please allow 6 to 8 weeks to process your rebate requests. Checks will be mailed to the address provided below.

**Program Eligibility and Rules**

1. Rebates are available July 1, 2015 through June 30, 2016 while funding lasts.
2. Your commercial property is connected to a participating sanitation system.
3. Your new fixtures and equipment have been installed and your rebate application is received or postmarked within 90 days of purchase or delivery. All purchases must be made between July 1, 2015 and June 30, 2016 to be eligible.
4. Incomplete applications and those without original purchase receipts will be returned.
5. For High-Efficiency Toilets:
  - Your commercial property was built before 1992.
  - The toilets you are replacing are designed to flush at more than 1.6 gallons per flush (generally, toilets manufactured before 1992).
  - Your new toilets are on the *List of Qualifying Models*.
  - Your old toilets were properly recycled or disposed of.
6. For High-Efficiency Clothes Washers:
  - Your new clothes washer is an EnergyStar® Most Efficient listed model.
  - Your old clothes washer was properly recycled or disposed of.
