**ADVERTISEMENT FOR BIDS**

- 1. **NOTICE.** The RUSSIAN RIVER COUNTY SANITATION DISTRICT (“Owner”), a local district of the State of California, hereby gives notice that it will accept Bids for construction of the following public work:

**Contract Number 70-13-7 #11**

**Russian River County Sanitation District Treatment Plant Disinfection Upgrade Project**

- 2. **DESCRIPTION AND LOCATION OF THE WORK.** The Work consists of construction of an ultraviolet light (UV) disinfection system at Owner’s treatment plant, 18400 Neeley Road, near the community of Guerneville, Sonoma County, California. The Work includes, but is not limited to, the construction of a low-pressure, high-output UV disinfection system in a 2-channel concrete basin; coagulation and flocculation facilities; a launder cover on one existing secondary clarifier; and piping, electrical and other modifications at the treatment plant. Bidding Documents contain the full description of the Work.
- 3. **ASSIGNMENT.** The District has entered into an agreement for manufacturing and supplying the UV System and related services with Ozonia North America. The Agreement for manufacturing and supplying the UV System and related services will be assigned to the successful low bidder for construction of the Project. Supplier consents to such assignment and novation, which shall be effected by executing the Assignment and Novation Agreement included in this Project Manual as Document 00525 (Assignment and Novation Agreement).
- 4. **ESTIMATED PROJECT COST RANGE:** \$2,090,000 to \$2,500,000.
- 5. **REQUIRED CONTRACTOR’S LICENSE(S).** A California “A” contractor’s license is required to Bid this Contract. Joint ventures must secure a joint venture license prior to award of this Contract.

7. **ELECTRONIC ACCESS TO BIDDING DOCUMENTS.** Bidders may view Bidding Documents on Owner's website: [www.sonomacountywater.org](http://www.sonomacountywater.org).
8. **PROCUREMENT OF BIDDING DOCUMENTS.** Bidders may examine Bidding Documents at Owner's Office. Bidders may obtain hardcopies of Bidding Documents upon payment of a non-refundable fee of \$40 for each copy. Owner will accept cash or checks payable to "Russian River County Sanitation District." Bidding Documents need not be returned to Owner. Bidding Documents contain a reduced set of Drawings. Bidders may arrange to obtain full-size Drawings from Digital Prints & Imaging, 375 Tesconi Circle, Santa Rosa, CA 95401, 707-546-0401, for an additional charge to be paid directly to Digital Prints & Imaging.
9. **FUNDING.** Owner advises potential Bidders that the Project is funded in whole or part with funds through the State Water Resources Control Board (SWRCB) State Revolving Fund Loan Program. Projects receiving federal funds must demonstrate that efforts were made to attract DBEs. The process to attract DBEs is referred to as the "Good Faith" effort. This effort requires the recipient, prime contractor and any subcontractors to take the steps included in Document 01415 (Regulatory Requirements - Funding) to assure that DBEs are used whenever possible as sources of supplies, construction, equipment or services. Bidding Documents contain further description of the requirements.
10. **MANDATORY PRE-BID CONFERENCE AND SITE VISIT.** Owner will conduct a Pre-Bid Conference at 10:00 a.m. on Tuesday, February 1, 2011, at 475 Aviation Boulevard, Santa Rosa, CA, to consider such matters as Bidders may request and a Pre-Bid Site Visit immediately following. A map showing the meeting place for the Pre-Bid Conference is included in Document 00201 (Pre-Bid Conference Vicinity Map). Bidders must attend Pre-Bid Conference and Site Visit and sign an attendance roster as a condition to bidding. The Pre-Bid Conference and Site Visit will last approximately 3 hours.

Owner will issue Minutes of the Pre-Bid Conference to all planholders and attendees, which shall constitute the sole and exclusive record and statement of the results of the Pre-Bid Conference. The Minutes issued by Owner are not Contract Documents.

Bidders will be provided the opportunity to investigate conditions or otherwise conduct invasive investigations, explorations, tests, or studies at the Pre-Bid Site Visit, subject to delivering an executed Document 00210 (Indemnity and Release Agreement) and providing an insurance certificate as described therein by noon of the Day prior to the Pre-Bid Site Visit. This will be the Bidders' only opportunity to investigate conditions at the Site. Bidders who intend only to observe Site conditions and not conduct such examinations are not required to provide an executed Document 00210 (Indemnity and Release Agreement) or an insurance certificate for the Pre-Bid Site Visit. The Pre-Bid Site Visit is merely a showing of the Site and existing conditions and will not provide an opportunity for Bidders to have questions answered. Bidders are encouraged, however, to submit written questions. Owner will transmit to all parties recorded as having received Bidding Documents such Addenda as Owner in its discretion considers necessary in response to written questions or questions arising at the Pre-Bid Conference. Bidding Documents will not be available at the Pre-Bid Site Visit.

Bidders shall not rely on oral statements. Oral statements will not be binding or legally effective.
11. **RESTRICTIONS ON SUBSTITUTIONS.** As a limitation on Bidder's privilege to substitute "or equal" items, Owner will not permit substitution on the UV disinfection equipment

specified in this Project Manual. Owner has previously performed a competitive selection process for the UV disinfection equipment and entered into a separate agreement with the supplier for manufacture and supply of the UV equipment. As to such items, Owner will not permit substitution.

12. **INSTRUCTIONS.** Bidders shall refer to Document 00200 (Instructions to Bidders) for required documents and items to be submitted in sealed envelopes for deposit into the Bid boxes, located at Owner's Office, and applicable times for submission.
13. **STATEMENTS OF QUALIFICATIONS.** Each Bidder shall be required to submit, in accordance with Document 00200 (Instructions to Bidders) and Document 00450 (Statement of Qualifications for Construction Work), a Statement of Qualifications.
14. **BID SUBMISSION.** Sealed Bids will be received at Owner's Office (see paragraph 6) until 1:00 p.m., Tuesday, February 22, 2011. Owner's staff will determine official time and will call out the designated time in the Bid reception area of Owner's Office, stating that the period for accepting Bids is closed. The Bid opening will be in accordance with procedures set forth in Document 00200 (Instructions to Bidders).
15. **BID PREPARATION COST.** Bidders are solely responsible for the cost of preparing their Bids.
16. **CONTRACT TIME.** Work shall be completed within **480** Days from the date when Contract Time commences to run.
17. **PAYMENT BONDS.** In accordance with California Civil Code Section 3247, payment bonds as set forth in Document 00200 (Instructions to Bidders) will be required from the successful Bidder.
18. **PREVAILING WAGE LAWS.** The successful Bidder must comply with all prevailing wage laws applicable to the Project, and related requirements contained in the Contract Documents.
19. **SUBSTITUTION OF SECURITIES.** Owner will permit successful Bidder to substitute securities for retention monies withheld to ensure performance of Contract, as set forth in Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention), in accordance with California Public Contract Code, Section 22300. By this reference, Document 00680 (Escrow Agreement for Security Deposits in Lieu of Retention) is incorporated in full in this Document 00100.
20. **RESERVATION OF RIGHTS.** Owner specifically reserves the right, in its sole discretion, to reject any or all Bids, or re-bid, or to waive inconsequential deviations from Bid requirements not involving time, price, or quality of the Work.
21. **INTERNATIONAL ORGANIZATION FOR STANDARDIZATION (ISO).** Owner is currently pursuing certification for ISO 9001 and 14001. Bidding Documents and Contract Documents contain information and requirements related to ISO.
22. **LABOR COMPLIANCE PROGRAM.** Owner operates a Labor Compliance Program (LCP) pursuant to Labor Code sections 1771.5 and 1771.7. All Contractors and Subcontractors shall be

required to comply with the LCP. The complete LCP is available upon request or at [www.3qcinc.com](http://www.3qcinc.com).
